Notice at Collection

This **Notice at Collection for California Employees** ("Notice") applies solely to all job applicants, employees, owners, directors, officers, and contractors (collectively referred to in this Notice as "employees") who reside in the State of California ("employee" or "you"). Use of Personal Information

Apex is collecting your personal information to support its business operations. We will not sell the personal information we collect nor use it for advertising purposes or to infer characteristics about you.

We may use, or disclose the Personal Information we collect for one or more of the following purposes:

- To fulfill or meet the reason you provided the information;
- Comply with all applicable laws and regulations;
- Recruit and evaluate job applicants and candidates for employment;
- Conduct background checks;
- Manage your employment relationship with us, including for:
 - o onboarding processes;
 - o timekeeping, payroll, and expense report administration;
 - o employee benefits administration;
 - o employee training and development requirements;
 - o the creation, maintenance, and security of your online employee accounts;
 - o reaching your emergency contacts when needed, such as when you are not reachable or are injured or ill;
 - o workers' compensation claims management;
 - employee job performance, including goals and performance reviews, promotions, discipline, and termination; and
 - o other human resources purposes;
- Manage and monitor employee access to company facilities, equipment, and systems;
- Conduct internal audits and workplace investigations;
